

**ANDHRA PRADESH POWER GENERATION CORPORATION LIMITED
ABSTRACT**

Estt.-APGENCO - Regulations - Permission for filling up of 50% vacant posts of Junior Accounts Officers (JAO's) earmarked for Direct Recruitment - One - time relaxation by promotion of eligible and qualified Senior Assistants against Direct Recruitment quota at Dr.MVR RTPP & Dr.NTTPS - Orders - Issued.

ORDER :-

As per Regulation 6 (b) of APSEB Service Regulations adopted by APGENCO, 25% of the sanctioned posts in the cadre of Junior Accounts Officers are earmarked for Direct Recruitment. The Regulation stipulated that every 4th vacancy in a unit of 4 sanctioned posts shall be filled or reserved for Direct Recruitment, and such vacancies are to be reviewed periodically.

2. In view of stagnation in the feeder cadre and representations received from the recognized Unions and Associations, the proposal for a one-time promotion of eligible and qualified Senior Assistants into the cadre of Junior Accounts Officers against the existing vacancies reserved for Direct Recruitment was placed before the HR Committee and in the meetings held on 21.03.2025 with the management of APGENCO and Service Association and consensus were arrived in subsequent meetings with management to consider the request of the Unions and Associations on one time basis.

3. After careful examination and in exercise of the powers conferred under Regulation 41 of Part-II of the APSEB Service Regulations (as adopted by APGENCO), the APGENCO hereby accords permission for a one-time relaxation of the recruitment norms to fill up the 50% Direct Recruitment quota vacancies of Junior Accounts Officers at Dr.MVR RTPP and Dr.NTTPS. Accordingly, all such vacancies existing as on the date of issuance of this G.O.O. shall be filled by promotion only with eligible and qualified Senior Assistants as stipulated in Annexure-III referred in Regulation 14 of A.P.S.E.B Service Regulations Part-III as adopted by APGENCO.

4. This relaxation is purely a one-time measure and shall not be treated as a precedent for future vacancies. The process shall stand closed upon filling up the vacancies identified as on the cut-off date. All future vacancies shall be ear marked for Direct Recruitment quota, till the permitted direct recruitment Junior Accounts
