ORDER:

3. Upon review of the approved lists as mentioned above, the following orders are issued:

(a) The position of the AEEs (who are finally allocated to APGENCO) enlisted in approved lists referred in para no.2 above, got repositioned as detailed in the Annexure appended to this order and the pay of incumbents whose date of promotion has been revised as indicated in the Annexure appended to this order, is to be regulated in terms of Regulation No.33 of APSEB SRs Part-I.

(b) Smt. Tara Padmaja [Emp.ID:1073269], AEE (Civil)/Dr.NTTPS is notionally promoted as Dy.EE (Civil) w.e.f. 27.03.2025 F.N and retained at Dr.NTTPS as DyEE(Civil). However, the notional promotee is entitled to monetary benefits from the actual date of assumption of charge as Deputy Executive Engineer (Civil) only, in terms of Regulation 33 of APSEB SRs Part-I, as adopted. The seniority of Smt. Tara Padmaja [Emp.ID:1073269], in the cadre of Dy.EE (Civil) shall be below Sri G.RameshBabu, Dy.EE(Civil) [now retired] [Emp ID:1016325] and above Sri C.Narendranatha Reddy, Dy.EE(Civil) [Emp.ID:1062575].

4. The other relevant terms and conditions in the promotion orders issued vide references 1st to 25th cited are unaltered.
