ORDER:

Under Reg.14 (a) (1) of APSEB Service Regulations Part-II, as adopted, 13 (Thirteen) No. Deputy Executive Engineers/Civil as mentioned in the Annexure appended to this order are promoted to act temporarily as Executive Engineers/Civil with effect from the date of assumption of charge, subject to the following conditions.

- a. The candidates promoted against the posts if not relieved and not reported within 15 days from the date of issue of these orders, they are deemed to have been relieved with effect from 21.01.2026 A.N.
 - b. They have to report at the place of posting as ordered within 15 days from the date of issue of orders, else the salary of the such employees shall be withheld by the respective Drawing & Disbursing Officers w.e.f. date of deemed relief.
 - c. Necessary disciplinary action will be initiated in terms of Regulation 4 (xix) of APSEB Disciplinary & Appeal Regulations, against the candidates who attempt to bring any political or other outside influence to bear upon any superior authority to further his interests in respect of change of posting.
2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto. It is without prejudice to the seniority of the officers that will emerge after review of FCG list of Assistant Engineers of Electricity Department as on 01.11.1956 is finalized.
3. The promotion ordered in para-1 above is liable to be reviewed based on the outcome of;
- a) The judgement to be delivered by the Hon'ble Supreme Court in the appeal filed against the judgement in W.P.No.2360-91/1983.
 - b) The judgement to be delivered in W.P.No.8509/1988 and 10937/1989 pending before the Hon'ble High Court of A.P., and
 - c) The judgement to be delivered in W.P.No.3470/2008 and W.P.No.1597/2010 pending before the Hon'ble High Court of A.P.

4. The 13 (Thirteen) No. Deputy Executive Engineers/Civil on temporary promotion as Executive Engineer/Civil, transfer of 01 (One) No. Executive Engineer/Civil and 1 No of Dy.EE/Civil (Relieved) on promotion as EE/Civil are posted to the places noted against their names in the Annexure appended to this order. The promotees/ Transferees are requested to assume charge as Executive Engineers/Civil, at the place of posting ordered.

5. The concerned controlling officers are requested to relieve the promotees/transferees duly making local arrangements, so as to enable them to assume charge as Executive Engineers (Civil) on promotion/transfer at the place of posting ordered. The alternative arrangements issued if any stands cancelled on assumption of charge by the concerned promotees/transferees.

6. The promotees are requested to assume charge on promotion as Executive Engineers/Civil at the place of posting ordered. The promotees are allowed for a joining time of 15 (Fifteen) days to join the post from the date of receipt of the order of appointment sent to them by register post with acknowledgement due or by any other means. If they fail to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, their promotion rights shall be forfeited for the current panel year and the names of such candidates shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O. 1st cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.

7. The orders are liable for revision without prior notice subject to outcome of orders of Hon'ble High Court against the Writ Petitions pending if any.

8. Leave salary, pension and Gratuity contributions shall be remitted by the deputation stations as per the G.O.O.No.178/JS (Per)/09, Dt: 07.08.2009.
