**ORDER:**

Consequent to review of approved lists drawn for promotion to the cadre of Deputy Executive Engineer (Elecl) from the cadre of Assistant Engineer/Additional Assistant Engineer (Elecl) [now re-designated as Assistant Executive Engineer/Assistant Engineer (Elecl)] due to revision of seniority of direct recruitees w.e.f. 01.02.1999 on merit basis issued vide reference 9<sup>th</sup> cited, the approved lists dated 07.03.2022, 25.08.2023 and 11.01.2024 drawn for promotion from the cadre of Deputy Executive Engineer (Elecl) as Executive Engineer (Elecl) are required to be reviewed in terms of Regulation No.8(2)(c) of APSEB Service Regulations Part-I as adopted.

2. b) Sri P.Ananda Rao [EmpID: 1069081], Dy.EE (Elecl)/Dr.M.V.R RTPP, is notionally promoted as EE (Elecl) w.e.f. 08.07.2024 F.N and continued at Dr.M.V.RRTPP as EE (Elecl) on notional promotion. However, the notional promotee is entitled to

monetary benefits from the actual date of assumption of charge as Executive Engineer (Elecl) only, in terms of Regulation 33 of APSEB SRs Part-I, as adopted.

The seniority of Sri P.Ananda Rao [EmpID: 1069081] in the cadre of EE (Elecl) shall be below Sri M.Ashok EE (Elecl) [Emp.ID:1068853].

c) Sri.M.Nageswara Reddy [EmpID: 1070255], Dy.EE (Elecl)/ Dr.M.V.RRTPP, is notionally promoted as EE (Elecl) w.e.f. 08.07.2024 F.N and continued at Dr.M.V.RRTPP as EE (Elecl) on notional promotion. However, the notional promotee is entitled to monetary benefits from the actual date of assumption of charge as Executive Engineer (Elecl) only, in terms of Regulation 33 of APSEB SRs Part-I, as adopted. The seniority of Sri M.Nageswar Reddy [EmpID: 1070255], in the cadre of EE (Elecl) shall be below Sri P.Ananda Rao [EmpID: 1069081].

(d) Consequent to the above revision of approved list

(i) Sri V VenkataNaik, EE (Elecl) [Emp.ID:1070485] is reverted as Deputy Executive Engineer (Elecl) w.e.f. 31.08.2023 F.N. and continued at Dr.MVR RTPP as Dy.EE (Elecl). (iii) Sri G Mallikarjuna Raju, EE (Elecl) [Emp.ID:1069030] is reverted as Deputy Executive Engineer (Elecl) w.e.f. 08.07.2024 F.N. and continued at Dr.MVR RTPP as Dy.EE (Elecl). His pay shall be regulated as per Note-4 of Regulation 33 of APSEB SRs Part-I, as adopted. The seniority of Sri G Mallikarjuna Raju in the cadre of Dy.EE (Elecl) shall be below Sri G.Brahmaji Rao [Emp.ID:1070335].

3. The other terms and conditions in the promotion order issued vide reference 2<sup>nd</sup> & 3<sup>rd</sup> cited are unaltered.
