ORDER:

Under regulation 14(a)(1) of APSEB Service Regulations Part-II as adopted, Sri V.Vijaya Sudhakar, AEE/Civil/SDSTPS is hereby promoted temporarily with effect from the date of assumption of charge as Dy.EE/Civil, subject to the following conditions.

- a. The candidate promoted against the post if not relieved and not reported within 15 days from the date of issue of these orders, he is deemed to have been relieved with effect from 29.01.2026 A.N.
 - b. He has to report at the place of posting as ordered within 15 days from the date of issue of orders, else the salary of the such employee shall be withheld by the respective Drawing & Disbursing Officer w.e.f. date of deemed relief.
 - c. Necessary disciplinary action will be initiated in terms of Regulation 4 (xix) of APSEB Disciplinary & Appeal Regulations, against the candidate who attempt to bring any political or other outside influence to bear upon any superior authority to further his interests in respect of change of posting.
2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto. The promotion is without prejudice to the seniority of the officers that will emerge after review of FCG list of Assistant Engineers of Electricity Department as on 01.11.1956 is finalized.
 3. The promotions ordered in para-1 above is liable to be reviewed based on the outcome of;
 - a) W.P.No.2360-91/1983 filed by Retired Officers of the Board and pending in the Supreme Court and W.P.No.77074/93, 17126/93, 5221/93,10199/92 pending before the High Court of A.P., and
 - b) W.P.No.19836/2000, W.P.No.3470/2008 and W.P.No.14264/2009 pending before the Hon'ble High Court of A.P.
 4. Sri V.Vijaya Sudhakar, AEE/Civil/SDSTPS(On Deputation) is repatriated to APGENCO and on temporary promotion as Dy.EE/Civil posted at USHES under the control of CE/O&M/LSHES, vice Sri G.Bhaskara Rao (Emp.ID:1068867), DyEE/Civil transferred. The remaining terms & conditions of the G.O.O. 1st cited are unaltered. On relief Sri G.BhaskaraRao, Dy.EE/Civil/ USHES, is hereby posted to Polavaram HEP against existing vacancy.

5. The concerned controlling officers are requested to relieve the promotee/transferee by making local arrangements, so as to enable them to assume charge at the place of posting ordered. The alternative arrangements issued if any stand cancelled on assumption of charge by the concerned promotee/transferee.

6. Sri V.Vijaya Sudhakar, AEE/Civil is directed to assume charge on promotion as Deputy Executive Engineer/Civil at the place of posting ordered. The promotee is allowed for a joining time of 15 (Fifteen) days to join the post from the date of receipt of the order of appointment sent to him by register post with acknowledgement due or by any other means. If he fails to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, his promotion rights shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O. 1st cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.

7. The orders are liable for revision without prior notice subject to outcome of orders of Hon'ble High Court against the Writ Petitions pending if any.
