ORDER:

In the reference 7th cited, APGENCO adopted the instructions issued by the Government vide reference 5th cited, wherein it was ordered that compassionate appointments shall be made to the post of Junior Assistant or to any other post carrying pay equal to or lower than that of Junior Assistant. Further, in Memo 8th cited, it has been ordered that "the Appointment to the post of JPA under compassionate grounds/Medical Invalidation candidates having the qualification of SSC/10th class with ITI shall be considered on par with qualification prescribed for the post of JPA through Direct Recruitment. However, the applicants having Diploma qualification shall also eligible for the post of JPA under compassionate grounds".

2. After careful examination of the matter, APGENCO hereby cancels the orders issued in the references 7th & 8th cited regarding adoption of instructions on compassionate appointments.

3. Accordingly, the orders and procedures that were in force prior to the instructions issued in the reference 7th & 8th cited shall stand restored, and compassionate appointments shall henceforth be processed and issued as per the earlier prevailing orders except for the post of JPA. The Compassionate Appointment to the post of JPA shall be considered to those having qualification of S.S.C. with I.T.I in line with other Power Utilities.
