ORDER:

Under Regulation 14 (a) (1) of A.P.S.E.B SR's Part-II, as adopted, Smt P.Kiranmayi, Emp ID: 1069374, Assistant Secretary is promoted temporarily to act as Deputy Secretary with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para-1 above is subject to the result of S.L.P.Nos.2360-91/83 filed by the Retired Officers of the erstwhile APSEB Board and pending in the Hon'ble Supreme Court of India and W.P.No.1173/91 pending in the Hon'ble High Court of Andhra Pradesh, and also subject to the outcome of W.P.No.39011/2017 and W.A.No.657/2024 pending in Hon'ble high Court of Andhra Pradesh.

4. It is further ordered that, upon the vacancy arised in the position of Deputy Secretary(ERP)/VS/VJA due to the promotion of the incumbent, said post shall be re-designated and utilized as Deputy Secretary(Services), falling under the administrative control of the Joint Secretary(Per)/ APGENCO/VS/VJA.

5. Accordingly, Smt P.Kiranmayi, Assistant Secretary, presently working under the control of the JS(Per), on temporary promotion as Deputy Secretary is posted as Deputy Secretary(Services) under the administrative jurisdiction of the Joint Secretary(Per)/ APGENCO/VS/VJA.

6. The Concerned Controlling Officers are requested to take necessary action by making local arrangements so as to enable her to assume charge at the place of posting ordered.

7. Smt. P.Kiranmayi, Assistant Secretary is ordered to assume charge on promotion as Deputy Secretary at the place of posting ordered. The promotee is allowed for a joining time of (15) fifteen days to join the post from the date of receipt of the order. If she fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, her promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in the reference 1<sup>st</sup> cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against her for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
