ORDER:

4. Sri P.MD. Sajid Ali Khan, Personnel Officer on promotion as Assistant Secretary ordered above is posted to the control of the Chief Engineer(O&M)/LSHES.
5. The Concerned Controlling Officer is requested to relieve the promotee by making local arrangements so as to enable him to assume charge at the place of posting ordered.
