ORDER:

In the reference 4th cited, the Government of Andhra Pradesh, have issued orders revising the Uniform Allowance from Rs.3,000/- to Rs.4,500/- per annum and Uniform Maintenance Allowance from Rs.150/- to Rs.200/- per month for employees belonging to uniformed services to those eligible for Uniform Allowance. Accordingly, the APGENCO adopted the above GoAP order with regard to allowances applicable for employees working on deputation with APGENCO vide reference 6th cited.

After careful examination of the matter, and in terms of the orders issued vide G.O 4th cited, sanction is hereby accorded to Enhance the Uniform Allowance from Rs.3,000/- to Rs.4,500/- per annum & Uniform Maintenance Allowance from Rs.150/- to Rs.200/- per month to the Security and Fire Service Personnel of APGENCO with effect from 01.06.2022.
