ORDER:

In the reference 1st cited, the GoAP has informed that “the pay scales of all the Directors irrespective of re-appointment of retired personnel may be maintained uniformity and, it is recommended to fix a lumpsum amount of Rs. 1,00,000/- and Rs. 90,000/- including DA, HRA and CCA minus pension per month for each Chairman & Managing Director (Non-Cadre) and Directors in APTRANSCO, APGENCO, and DISCOMs respectively towards their remuneration instead of pay scales for holding the post of Chairman & Managing Director and Director excluding other allowances if any fixed by the respective Boards and above said lumpsum amount may be enhanced by 10% every year”.

2. Further, in the Letter No. 2390/Pr.III (1)/2006, Dt:25.10.2010, the Government of A.P has implemented the following recommendations of Anomalies Committee constituted w.e.f. 29.09.2010 in respective of APGENCO. The same was adopted vide G.O.O. No. 551/JS(Per)/2013, Dated: 19.11.2013.

- i) To fix a lumpsum amount of Rs. 1,00,000/- and Rs. 90,000/- including DA, HRA and CCA minus pension per month for Chairman & Managing Director (Non-Cadre) and Directors respectively in APTRANSCO, APGENCO and DISCOMs towards their remuneration instead of Pay Scales.
- ii) To Pay other allowances, if any, fixed by the respective Boards;
- iii) To enhance the above said lumpsum amount by 10% every year.

3. The above issue has been discussed by APPCC on 30.03.2026 and communicated the resolution on the subject vide reference 4th cited above, APPCC has resolved the following:

- a) To have parity with all power utilities in the sector in respect of remuneration to the Directors, committee recommends to have uniform pay & allowances structure and taxation.
- b) Duly considering GoAP Letter dated 13.07.2010. with allowable escalation of 10%, the monthly lumpsum pay to the Directors (including all power utilities) at Rs. 3,75,955/- minus (-) pension, up to a period of three years w.e.f. 1st April-2026, is fixed as proposed.
- c) If accommodation is availed the proportionate HRA amount will be excluded from the monthly lumpsum amount.
- d) MC/APPCC to gather various allowances sanctioned to Directors across all power utilities and streamline the same and issue orders from APTRANSCO for uniform allowances across all utilities for adoption.

4. In the view of the above APPCC resolution, the lumpsum remuneration for the Directors of APGENCO, is hereby fixed at Rs. 3,75,955/- per month (inclusive of DA, HRA and CCA) minus pension, up to a period of three years w.e.f 01.04.2026 with the applicable allowances. If accommodation is availed, the proportionate HRA shall be deducted. However, the applicable allowances will be examined and orders will be issued separately, basing on the recommendations of the Member Convenor/APPCC.

5. The Pay Officer/APGENCO/Vidyut Soudha/Vijayawada is authorized to draw and disburse the above lumpsum remuneration with the applicable allowances which are being paid currently to the concerned individuals until further orders.

6. These orders issued with the concurrence of the Director (Finance & Commercial) APGENCO.
