**ORDER:**

Under Reg.14 (a) (1) of APSEB Service Regulations Part-II, as adopted, Smt.P.Anuradha (Emp.ID 1016990), Superintending Engineer/Elecl is promoted temporarily to act as Chief Engineer/Elecl with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para-1 above is without prejudice to the seniority of the officers that will emerge after review of FCG list of Assistant Engineers of Electricity Department as on 01.11.1956 is finalized.

4. The promotion ordered in para-1 above is liable to be reviewed based on the outcome of ;

- a) W.P.No.2360-91/1983 filed by Retired Officers of the Board and pending in the Supreme Court and W.P.Nos.77074/93, 17126/93, 5221/93, 10199/92 pending in the High Court of A.P., and
- b) W.P.No.19836/2000, W.P.No.3470/2008 and 14264/2009 pending before the Hon'ble High Court of A.P.

5. Smt.P.Anuradha (Emp.ID 1016990), Superintending Engineer/Elecl working under the control of Chief Engineer/O&M/Dr.NTTPS, on temporary promotion as Chief Engineer/Elecl is hereby posted as **Chief Engineer/TPC/VS/Vijayawada.**

6. The Chief Engineer/Generation/VS is directed to handover the works of Chief Engineer TPC/Vidyut Soudha to the promotee on assumption of charge.

7. The Chief Engineer/O&M/Dr.NTTPS is requested to relieve Smt.P.Anuradha, Superintending Engineer/Elecl by making local arrangements, so as to enable her to assume charge as Chief Engineer/Elecl at the place of posting ordered above. The alternative arrangements issued if any stand cancelled on assumption of charge by the concerned promotee.

If she fails to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, her promotion rights shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O. 1<sup>st</sup> cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against her for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.

9. The orders are liable for revision without prior notice subject to outcome of orders of Hon'ble Supreme Court/ Hon'ble High Court against the Writ Petitions pending if any.
