**ORDER:**

Under Reg.14 (a) (1) of APSEB Service Regulations Part-II, as adopted,Sri.R.Rajendra Kumar (Emp ID:1061040) Assistant Engineer/Mech is promoted to act temporarily as Deputy Executive Engineer/Mech with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto.
3. The promotion ordered in para-1 above is without prejudice to the seniority of the officers that will emerge after review of FCG list of Assistant Engineers of Electricity Department as on 01.11.1956 is finalized.
4. The promotion ordered in para-1 above is liable to be reviewed based on the outcome of :
  - a) The Judgment to be delivered in W.P.No.2360-91/1983 filed by Retired Officers of the Board and pending in the Supreme Court of India.
  - b) The Judgment to be delivered in W.P.No.17529/97 pending before the Hon'ble High Court of A.P.
5. Sri.R.Rajendra Kumar (Emp ID: 1061040), Assistant Engineer/Mech working under the control of Chief Engineer/O&M/Dr.MVR RTPP on temporary promotion as Deputy Executive Engineer/Mech is posted as Deputy Executive Engineer/Dr.MVR RTPP under the control of Chief Engineer/O&M/Dr.MVR RTPP. The promotee is directed to assume charge as Deputy Executive Engineer/Mech after obtaining proper relief at the place of posting ordered.
6. The concerned controlling officer is directed to relieve the promotee by making local arrangements, so as to enable him to assume charge at the place of posting ordered above. The alternative arrangements issued if any stand cancelled on assumption of charge by the concerned promotee.

The promotee is allowed for a joining time of 15 (Fifteen) days to join the post from the date of receipt of the order of appointment sent to him by registered post with acknowledgement due or by any other means. If he fail to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, his promotion rights shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O. 1<sup>st</sup> cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.

8. The orders are liable for revision without prior notice subject to outcome of orders of Hon'ble Supreme Court/ Hon'ble High Court against the Writ Petitions pending if any.
