As per the orders issued vide reference 11<sup>th</sup> cited, certain employees who were retired on attaining the age of 58 years have remitted back the terminal benefits along with interest thereon upto date of repayment and were re-inducted into service. Subsequently in the reference 14<sup>th</sup> cited, it has been ordered that the retired employee who is unable to remit back the said terminal benefits he/she need not to remit the same (except retirement gratuity) but his/her re-induction, he/she shall pay the interest @ 9% per annum on the amount received towards terminal benefits, during his/her future retirement and if the said interest amount is not paid, such interest amount shall be deducted from his/her monthly salary. At para 6 (c) the above benefits will also be applicable to employees who are already re-inducted into service in accordance with orders issued vide memo 11<sup>th</sup> cited. In the reference 15<sup>th</sup> cited, the orders issued vide memo 14<sup>th</sup> cited has been modified and the retired employees were permitted to re-induct into service without remittance of terminal benefits. It was also ordered therein the other conditions of the memo 14<sup>th</sup> cited remains unaltered.

02). Certain retired employees who were remitted the terminal benefits along with interest thereon in terms of orders issued vide memo 11<sup>th</sup> cited have represented, vide reference 16<sup>th</sup> cited, to arrange to refund the interest paid by them as per Clause 6 (c) of the memo 14<sup>th</sup> cited.

03). After careful consideration, it is hereby ordered that the interest remitted by the retired employees on terminal benefits in terms of orders issued vide memo 11<sup>th</sup> cited and are re-inducted into service shall be refunded to them.
