They are requested to communicate the same to all the offices (Both Central and State Governments) in their district to enable them to grant Special Casual Leave on the day of poll (i.e., 22.03.2019) to their employees who are bonafide voters in the said constituencies.

In the reference 1<sup>st</sup> cited, the Chief Electoral Officer has requested that all the Private Managements/authorities of business, trade, industrial undertaking or other establishments in the state to grant necessary facilities to their employees who are registered cvoters in any of the Graduates/Teachers'/Local Auhtorities'constituencies, such as permission to attend office/duty late; adjustments of shifts; short absence of duty hours or otherwise, so as to enable them to exercise their right of franchise to vote on the day of poll (i.e., 22.03.2019) (Friday) between 8.00 AM to 4.00 PM. .

After careful examination, the APGENCO hereby permit to avail one day Special Casual Leave on 22.03.2019 (Friday) to the employees of APGENCO working in Srikakulam, vizianagaram, Visakhaptnam, Guntur, Krishna, East Godavari, and West Godavari Dsitriacts of Andhra Preadesh State who are having their voting rights to cast their vote subject to production of bonafide to the leave sanctioning authorities.

04). All the concerned leave sanctioning authorities are directed to sanction Special Casual Leave to eligible employees subject to production of bonafide.
